# **Privilege of the Floor:**

Kelly Kent: Inquiring on the status of her end of Fridley Road. - Boards decision

Steve Ricci Town Attorney The Towns abandonment of Fridley Road does not include her portion of the road..

Kevin Conley: Thanked Assessor Cleere for crediting his tax bill for his not having water. Wanted Board to know he still wants water.

Steve Ricci, Town Attorney, will speak to Jason McCormick about getting water hook up to the Conley's. Councilman Trout will speak with Rick Conley about assisting with the hook up installation as previously offered. Town Board should have information in the next couple of weeks and is hopeful Mr. Conley will have his water hooked up later this year.

Blaine Murray: Has water concerns for his residence on Watts Road.

**Code Enforcement Officer: Robert Steele-** Five Building permits were approved. Complaint form has been corrected and can now be implemented. **Town Assessor Report: Jim Cleere-** Deadlines to file exemptions is March 1<sup>st</sup>, 2017. Gas Well values have declined and there are new Ag. Values. Enhanced Star program is now forever, not a year.

The Town Of Fayette demands that Seneca County investigate these severe irregularities, the effect on the other bidders, and the impact on the taxpayer.
