Public Notice of the meeting was posted in the Sunday, July 15, 2018 edition of the Finger Lakes Times and on the Town of Fayette Website.

Public Hearings:

The Public Hearing for Micael Karsten of 3056 NY State Route 89, Seneca Falls, NY 13148, Town of Fayette – Tax Map 08-1-07 for a Site Plan Review to build a 28'X36' pole barn on 2.01 acres. The drive to the barn is along the right side of the house. No plans to black top it. The drainage is that the ground is graded to the ravine. Slope is 2-1 for about 15 feet. Water to be installed, the drainline to a sump pump. Mr. Karstein will be in contact with his plumber. The map is a 2009 and the property has not had any alterations to it. The storage barn will be two story – the proposed plan has been added to the record. It will have 3 doors and the 2nd story will be unfinished. A motion to close the Public Hearing was made by Sandy Caster, 2nd by Mark Lott; no further questions; all in favor, Hearing closed.

Preliminary Hearings

The Preliminary Hearing of Joshua Asermily of 4208 Teall Beach, Geneva, NY 14456, Town of Fayette – Tax Map 26-1-55 in regards to building a residence on .67 acres. Mr. Asermily would like to build a Cape Code style 2 story home with dormers facing the road and a walk-out on the lake side. The location of the dwelling would line up with the neighbors. The property has a

garage. It was stated that the parcel is a non-conforming / preexisting lot. Ideas to make the property workable were:

A: the existing footprint – just the pad

B. The pad and a sun room (removal of shed)

C. The pad, sun room, and garage (removal of current shed and garage) this would give the most amount of footage available to use. The height restriction is 35 feet.

Things to keep in mind in planning is the retention and detention system for water. Sump systems, rain gardens were mentioned. Currently the septic is draining to the lake - this of course Mr. Asermily stated would be corrected. A motion to close the Preliminary Hearing was made by Mark Lott, 2nd by David Fitzgerald, all in favor; Preliminary Hearing Closed

The Preliminary Hearing of Bernard Lynch of 3778 Kime Beach Road, Geneva, NY 14456, Town of Fayette – Tax Map 18-1-10 in regards to building a deck on .27 acres. As Mr. Lynch was not present this; the Preliminary was closed.

The Preliminary regarding a potential Site Plan for 3684 Edgewood Drive, Geneva, NY 14456, Town of Fayette, - Tax Map 18-1-44 regarding the placement of a Yurt on 1.5 acres. The party that had questions was not present Preliminary was closed.

Planning Board Member Mark Lott recused himself from the table.

The Preliminary Hearing of Mark & Kathleen Lott of 2450 County House Road, Waterloo, NY 13165 regarding the building of a 16'X16' deck on 4397 NY State Route 89, Seneca Falls, NY 13148, Town of Fayette – Tax Map 30-2-25. The plans for the deck were added to the record. The deck is meeting all set backs and does not encroach on any viewsheds. It was commented that it is a very basic and straightforward plan.
