**Motion from Supervisor Lorenzetti and seconded by Councilwoman to adopt Local law No# 2 of 2021, regarding a resolution subject to permissive referendum. 4/1 Carried
Councilman Goff opposed**

Motion from Councilwoman Zwick and seconded by Councilman Goff to approve the minutes from September 9th, 2021 with a spelling correction, to change Cierra Masteller name to begin with a "C". 3/0 with Lorenzetti and Lowry abstaining, as they were absent last meeting.

Motion from Councilman Trout and seconded by Councilman Goff to approve of Supervisor Lorenzetti signing the contract between the Town and the Highway workers, IBT Local 118. 5/0 Carried

Motion from Councilman off and seconded by Councilwoman Zwick to Appoint J. Sweenburg as foreman for the Highway Department, starting next payday. 5/0 Carried

Motion from Councilman Trout and seconded by Councilwoman Zwick to award Judy Brignall (Court Clerk), the same award of service that Sue Hensel is receiving, \$150 dollars for each year of service. For Judy that will be 42 years at \$150 dollars, equaling \$6300.00 total. 5/0 Carried

Modifications to tentative budget for 2022

Motion from Councilwoman Zwick and seconded by Councilman Goff to keep line A7450.4 at \$3000.00, but only to release funds, contingent on the fund raising that the Historical Society does. The Town will match, up to \$3000.00 . 5/0 Carried

Motion from Councilman Trout and seconded by Councilman Goff to restore the Historian position, Line A7510.1 at \$600.00 per year, to be appointed in January. 5/0 Carried

Motion from Councilman Trout and seconded by Councilwoman Zwick to add \$1.00 to line A1220.11. 5/0 Carried

Motion from Councilman Trout and seconded by Councilwoman Zwick to add \$16380.00 To line A9060.8 in case new account clerk will need medical insurance. 5/0 Carried

Motion from Councilman Trout and seconded by Councilwoman Zwick to adjust line A1910.4 to \$17700.00 for FL Partners for insurance increase next year. 5/0 Carried

Motion from Councilman Goff and seconded by Councilwoman Lowry to put line A5010.1 back to its original amount of \$57043 and add 3% for the 2022 year, putting the Highway Superintendent at \$58,755.00 5/0 Carried

Motion from Councilwoman Lowry and seconded by Councilman Goff to increase Social Security on line A9030.8 to \$19,845.00 4/0 Carried
