04/13/2023**

**Supervisor Trout called the meeting to order at 7:00 pm with the Pledge of Allegiance & welcoming the Boy scouts who came to listen.**

**PRIVILEGE OF THE FLOOR:**

Harriet Haynes from the County spoke about Farmland protection, this would provide opportunity for farm operations to put in applications through the Soil & Water office. This is a State program and it will go through the Board of Supervisors first then to Ag & Markets for re-certification of the district.

Bob Stivers- Stivers Point PUD Application proposal for 54 unit townhome project at 401 Boody's Hill Road. The time frame for this project is expected to be a few years and the cost is around one million dollars.

**CODE ENFORCEMENT REPORT:**

4 Approved permits for March. A letter was sent to a home owner stating that they have violated the Land Use Regulations of the Town of Fayette.

**TOWN ENGINEER REPORT:**

Only received one very excessive bid for 1.4 million dollars for thirty five hundred feet of water line, that amount is double what it should have been.

**SUPERVISOR REPORT:**

The County Soil & Water has requested a new technician and has been approved, the new AG tech will start on May 1st. There are some good candidates for the County manager position. Holding off on McManus IT for now, would like to have Kieran come to a meeting.
